### IMPORTANT INFORMATION

#### General rules/procedures

- Students must arrive on time and attend all morning and/or afternoon classes and activities. If students are ill, they must notify a member of staff before 8am.
- Students will be supervised by their group leader or a member of NCG staff at all times.
- NCG reserves the right to ask a student to leave because of misconduct (unacceptable behaviour), non-payment of fees or non-attendance and they will be subject to disciplinary procedures.
- All students and staff at NCG are expected to show respect to each other at all times. Harassment, bullying, actual or threats of violence, damage to personal property and verbal abuse based on racial, sexual or religious differences will not be tolerated and disciplinary action may be taken.
- Students must keep their room and personal belongings clean and tidy. NCG staff have the right to enter and search bedrooms.
- Students are not allowed off campus unless supervised by their group leader or a member of NCG staff. (Not applicable to homestay students or students living off-site)

#### Behaviour guidelines

- · UK law must be adhered to at all times.
- Students must be over 18 years old to buy and consume alcohol and cigarettes in the UK.
- · Do not buy or take illegal drugs.
- Do not be tempted to take anything without paying. Students may be arrested and prosecuted for shoplifting.
- It is strictly prohibited to drink alcohol, take drugs, smoke cigarettes or engage in sexual activity during Junior Summer School.

#### Discipline procedures

- · Verbal warning by Director of Studies/Director
- Written warning by Director of Studies/Director to students and parents.
- Final written warning by Director of Studies/Director to students and parents.
- Expulsion. Parents must arrange immediate transport back to their country of origin.
